- Nominations are open to individuals actively involved in farming and/or growing enterprises in New Zealand and individuals providing rural services in New Zealand.
- Entrants must be nominated by a third party.
- Entrants must be over 18 years of age and eligible to work and live in New Zealand. Proof such as a New Zealand Driver's License, Passport or Birth Certificate must be provided if requested.
- Entrants must be able to demonstrate their farm is run in a sustainable and ethical manner.
- Nomination forms and related information remain the property of Allied Press. Information and any photos provided by the entrant may be used for promotional purposes and made available to Award Sponsors.
- Entrants may be required to fulfil promotional duties as requested by Allied Press and the Award Sponsor; including but not limited to media interviews
- Entrants agree they will not behave in any way that may bring the Rural Champions campaign and competition, Sponsors and/or Allied Press into disrepute, including social media. A determination of what constitutes misconduct is at the sole discretion of Allied Press management and/or Contest Sub-Committee and may result in entry revocation and disqualification.
- Entrants may be subject to a social media audit, to be completed by Allied Press. Should evidence be found of social media posts that may publicly bring the Rural Champions campaign and competition, fellow competitors, Allied Press or Sponsors into disrepute or if the post is deemed defamatory (in the sole discretion of Allied Press) then the contestant will be asked to remove the post immediately. Failure to do so could result in disqualification.
- The Entrant agrees that no direct communication shall be entered into with any judge, member of the media, Sponsors or Officials. Any correspondence should be directed in the first instance to the Allied Press Team in a letter, private email or verbal conversation but must not be conducted via social media with respect to a dispute.
- The Entrant agrees to the rules, regulations and directions expressed or implied by the Allied Press Team, sponsors and officials. A breach of these Rules and Conditions may result in the withdrawal of their entry, or disqualification.
